2. Applicants must bring their own table/chairs/tents/booths; etc...the Sowebohemian Arts and Music Festival does not supply these.
3. The Festival Planning Committee will assign your vending space on the festival grounds. There will be no changing of assignments the day of the festival.

Arts and Crafts Vendor Application Form Guidelines:

4. Vending Spaces must be set up by 11:30 am on the day of the festival, Sunday, May 28, 2017.
5. Tear down of your space may not begin before 7:00 p.m. on Sunday, May 28, 2017 (weather permitting).
6. NO VENDOR VEHICLES ARE PERMITTED ON FESTIVAL GROUNDS BETWEEN 11:00 AM AND 7:00 PM DURING THE FESTIVAL ON SUNDAY May 28, 2017
7. Vending Spaces MUST be left clean. Trash must be disposed of in festival cans. Our neighbors appreciate these efforts.
8. Incomplete or illegible applications may have to be resubmitted. The festival committee reserves right to deny any application.
9. No alcoholic beverages are allowed within the festival grounds which are not purchased from approved vendors. The revenue from alcohol sales provides for the majority of the festival budget, as well as supports neighborhood schools and nonprofit organizations. Each beverage you purchase helps to support the arts in our neighborhood, and ensure that the festival can continue each year. Failing to comply may result in expulsion from this and future festivals.
10. There is a \$20.00 penalty for bounced checks.
